18. The school/governing body shall strictly follow the rules and directives of the Government and the Department.

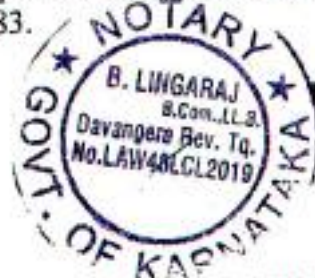
19. Mandatory uploading of school information in S.A.T.S. by the end of March every year.
